

MINISTERIAL REGULATION No. 3 (B.E. 2540) (1997) ISSUED BY VIRTUE OF THE BUSINESS REGISTRATION ACT, B.E. 2499 (1956)

By virtue of the provisions of section 4, section 11 paragraph one and section 13 of the Business Registration Act, B.E. 2499 (1956), the Minister of Commerce issues this Ministerial Regulation, as follows.

Clause 1. There shall be repealed:

- (1) Ministerial Regulation (B.E. 2499) (1956) Issued by Virtue of the Business Registration Act B.E. 2499 (1956); and
- (2) Ministerial Regulation No. 2 (B.E. 2514) (1971) Issued by Virtue of the Business Registration Act B.E. 2499 (1956).
- **Clause 2.** An application for registration of a business, an application for registration of the alteration of particulars or an application for registration of the cessation of a business shall be in accordance with the Tor. Por. Forms annexed hereto.
 - **Clause 3.** Fees shall be prescribed in accordance with the rates annexed hereto.
- **Clause 4.** Business registration certificates (Tor. Por. 4 Form) issued to operators of businesses prior to the date of the entry into force of this Ministerial Regulation shall remain valid until the operators of the businesses apply for new business registration certificates.
- **Clause 5.** All applications for registration or other applications filed prior to the date of the entry into force of this Ministerial Regulation and pending official consideration shall be deemed the applications under this Ministerial Regulation *mutatis mutandis*.
- **Section 6.** This Ministerial Regulation shall come into force after ninety days as from the day following the date of its publication in the Government Gazette. **

Note:- The reasons for the promulgation of this Ministerial Regulation are as follows. Whereas it is expedient to revise business registration forms and application forms under the law on business registration in order that the forms and statements therein shall be appropriate and suited to registration work schemes as well as business data of the present time and in endeavor to reduce unnecessary documents for convenience of applicants and lessen official burdens in the examination and retention of such documents and whereas section 11 paragraph one and section 13 of the Business Registration Act, B.E. 2499 (1956) provide that application for registration of a business and application for registration of an alteration of any particulars in the business register and of a cessation of a business shall be in accordance with the forms prescribed in the Ministerial Regulation, it is therefore necessary to issue this Ministerial Regulation.
