## **MINISTERIAL REGULATION**

## PRESCRIBING RATES OF FEES FOR REGISTRATION, INSPECTION OF DOCUMENTS, CERTIFIED COPIES OF DOCUMENTS AND OTHER FEES IN RELATION TO PARTNERSHIPS AND LIMITED COMPANIES, B.E. 2549 (2006)

By virtue of the provisions of section 1018 and section 1020 of the Civil and Commercial Code, the Minister of Commerce issues this Ministerial Regulation, as follows.

## Clause 1. Fees shall be prescribed as follows:

(1) Registration of a partnership
Every amount not exceeding 100,000 Baht
of the fixed capital; 100 Baht
provided that a fraction of 100,000 Baht
shall be reckoned as 100,000 Baht.
Minimum fee being 1,000 Baht
Maximum fee being 5,000 Baht

- (2) Registration of new membership of a partnership or an alteration of contributions of partners
  - (a) Registration of an increase of the amount of contributions of partners
    Every amount not exceeding 100,000 Baht of the increased portion of the capital; 100 Baht provided that a fraction of 100,000 Baht shall be reckoned as 100,000 Baht.

    Maximum fee being 5,000 Baht

(17)A request for written certification of statements entered in the Register, including certificates summoned by a warrant of the Court In the case of a request for written certification of statements entered in the Register of a partnership or a limited company outside the responsible area of the Partnerships and Companies Registration Office where its principal business office is located or in the case of an online request for written certification of statements entered in the register: subject to such necessary additional fees as prescribed by the Notification of the Central Registrar.

(18) Transfer of computer data

Fee 1,000 Baht for each request

Fee for saving data the record of which consists of not more than two hundred characters In the case where the record consists of more than two hundred characters, the fee is charged on the basis that every two hundred characters shall be reckoned as one record.

A fraction of two hundred characters shall be reckoned as one record.

In this Clause, "record" means a unit of data stored in a database programme and retrievable in the form of characters in each line.

**Clause 2.** Fees collectible on applications filed prior to the date of the entry into force of this Ministerial Regulation shall be collected in accordance with the rates of fees in force at the time of the filing of such applications.

**Note**:- The reason for the promulgation of this Ministerial Regulation is as follows. Whereas the rates of fees for registration of partnerships and limited companies, inspection of documents, certified copies of documents and other fees in relation to partnerships and limited companies have been in force for a long period of time and become outmoded in view of economic circumstances of the present time, it is expedient to revise such fees to ensure their greater appropriateness. It is therefore necessary to issue this Ministerial Regulation.
